All other components are Copyright © 2026 CAST S.A. All rights reserved. The CAST Imaging Express Analyzer is made available via the CAST Imaging website and, to the extent applicable to the End User, is governed either by: (i) the previously and mutually agreed CAST Imaging Express Terms and Conditions as outlined in an executed agreement for the use of the Services; or (ii) by the CAST Imaging Express Terms and Conditions available in electronic format at the URL: <https://doc.castsoftware.com/imagingexpress/legal/terms-conditions/> if the End User is not in privity of contract with CAST.
